#### 2.1 filter on document type in RECORDCHANGEEVENT

In the following out of the box EDI connections, filters are applied to refer to sales orders and purchase orders. The filter is set to Document is Released. This means, that when a Sales/Purchase Order is released, the Pipeline gets triggered. Before the case was that all sales & purchase documents were taking into account during the trigger process.

- TI\_EDI\_1.PO.OUT filter on the "Document Type" in the RECORDCHANGEEVENT
- TI\_EDI\_3.CONF.OUT filter on the "Document Type" in the RECORDCHANGEEVENT
