1. Purpose

This document describes the fixes implemented in To-Increase Food Manufacturing & Distribution for Microsoft Dynamics 365 Business Central 2022 Release Wave 1.

This release replaces Food for Microsoft Dynamics 365 Business Central 2021 Fall Update and is based on Update 20.2 for Microsoft Dynamics 365 Business Central 2022 Release Wave 1 (Application Build 20.2.202207).

2. Audience

This document is primarily meant for product- and implementation consultants familiar with the concepts of Food Manufacturing & Distribution.

This document explains the content of the delivery package to consultants of To-Increase partners.

2.2 OnlineHelp especially for EmbedApp

The EmbedApp may respond differently in some cases than the standard Microsoft Dynamics 365 Business Central SaaS environment.

We see this especially when installing 3rd Party ISV apps and when using so-called Connector Apps.

3. Deliverables

Besides 2 On-Premise packages (W1 & NA) we also deliver a SaaS EmbedApp package.

This SaaS EmbedApp is only available in the USA, localized as NA, in a Microsoft Azure Cloud environment, managed by To-Increase.

The extensions in the TI- ... folders are mandatory and part of the base installation for To-Increase applications. They are also "Excluded" from the Extension Management page to limit the number of extensions shown.

- Refer to Checklist to create a demo database with extended CRONUS data to learn how to create a demo database from the included resources.
- For ESHA we deliver interface-data for the Genesis-module and database
- For Food Label Connections we provide two examples of labels, 1 for containers and 1 for cases. To be used with the Labelprinting module.
- For Food Lifecycles a number of example-lifecycles are available for ILM in Food.

• For Food Anywhere the out of the box processes are delivered for the Warehouse Scanning Solution BC Anywhere.

We deliver Runtime Packages for Business Central On-Premises. When the runtime package is generated on the server, the developer license is checked for permissions to the used extension IDs. The extension in a runtime package can then be installed on servers that do not have a developer license; the server only needs permissions to run the objects, but not to modify or insert them.

As US EmbedApp follows Modern Lifecycle Policy of Microsoft it follows the majors and minors for Microsoft Dynamics 365 Business Central SaaS.

5. New Features Summary

This is a major release where the functionality is migrated as is and adapted to new Microsoft Dynamics 365 Business Central features as needed.

Newly added! Quality Control Additional Test:

Imagine that Quality Control Tests are performed as usual but due to specific customer requirements or specific country/customs requirements you need to test this lot with other test.

It is now possible to add Data Elements or Data Templates to a Lot Quality Test which insert new lines to test.

As Microsoft made changes or added features to Business Central we adjusted Food to this:

- _Exclude Bank Deposits app was added by Microsoft we made a Food Bank Deposits extension: This provides support for deduction management
- Set Default Dimensions on Locations: This was only done for Maintenance and comes into effect when work orders are created.
- Check documents and journals in while you work:
 - o Added to terminal market and commodity purchase order
 - o Added to Bin Reclass and Phys. Inventory (Food version) journals
 - o Error capture added to Food validations when posting item journals specifically related to container assignment and loose inventory

Microsoft is continuously adding new features in the application directly and via Feature Management. Sometimes these are public preview and will be made generally available in future releases, in other cases, they are already general available, and you have the choice to activate them.

Currently, we are not testing compatibility with all new features or combinations.
