1. Purpose

This document describes the fixes implemented in To-Increase Food Manufacturing & Distribution for Microsoft Dynamics 365 Business Central 2022 Release Wave 1.

This release replaces Food for Microsoft Dynamics 365 Business Central 2021 Fall Update and is based on Update 20.4 for Microsoft Dynamics 365 Business Central 2022 Release Wave 1 (Application Build 20.4.202403).

2. Audience

This document is primarily meant for product- and implementation consultants familiar with the concepts of Food Manufacturing & Distribution.

This document explains the content of the delivery package to consultants of To-Increase partners.

2.2 OnlineHelp especially for EmbedApp

The EmbedApp may respond differently in some cases than the standard Microsoft Dynamics 365 Business Central SaaS environment.

We see this especially when installing 3rd Party ISV apps and when using so-called Connector Apps.

3. Deliverables

Besides 2 On-Premise packages (W1 & NA) we also deliver a SaaS EmbedApp package.

This SaaS EmbedApp is only available in the USA, localized as NA, in a Microsoft Azure Cloud environment, managed by To-Increase.

The extensions in the TI- ... folders are mandatory and part of the base installation for To-Increase applications.

- For ESHA we deliver interface-data for the Genesis-module and database
- For Food Label Connections we provide two examples of labels, 1 for containers and 1 for cases. To be used with the Labelprinting module.
- For Food Lifecycles a number of example-lifecycles are available for ILM in Food.

• For Food Anywhere the out of the box processes are delivered for the Warehouse Scanning Solution BC Anywhere.

We deliver Runtime Packages for Business Central On-Premises. When the runtime package is generated on the server, the developer license is checked for permissions to the used extension IDs. The extension in a runtime package can then be installed on servers that do not have a developer license; the server only needs permissions to run the objects, but not to modify or insert them.

As US EmbedApp follows Modern Lifecycle Policy of Microsoft it follows the majors and minors for Microsoft Dynamics 365 Business Central SaaS.
